

The regular meeting of the Huntingdon County Commissioners was held on the above date and time in the Commissioner's Meeting Room with the following present: Commissioners Walls and Reeder; Solicitor, Larry Newton; Chief Clerk, Heather Fellman; CYS Director, Kelvin Abrashoff; Trish Norris and Jonathan Hyde from the Elks and Daily News Reporter, Byron Mantoan.

The meeting was called to order at 9:30 a.m. by Commissioner Walls. Prayer was led by Commissioner Walls and the Pledge of Allegiance to the flag was led by Commissioner Reeder.

It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes) to approve of the minutes of the previous meeting.

It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes) to approve payment of bills.

There were two additions to the agenda. The first addition was Proclamation 11-2025 for the Elks. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes). The second was consideration of approval to hire a CYS Caseworker. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Under announcements, Commissioner Walls discussed tomorrow's recycling event open to Huntingdon County residents at the Fairgrounds from 2-6pm.

There were no public comments.

There were no matters to be addressed by the Solicitor.

Under new business, Trish Norris and Jonathan Hyde of the Elks requested consideration of approval for Proclamation 11-2025 to commemorate the 120th birthday of Elks Lodge #976 on June 21, 2025. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Kelvin Abrashoff, CYS Director, requested consideration of approval for a purchase of service agreement with Intrinsic Intervention for drug testing services. This is a renewal for contract year July 1, 2025 through June 30, 2026. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Kelvin Abrashoff requested consideration of approval for a purchase of service agreement with the Children's Advocacy Center of Centre County for forensic interviews and medical exams. This is a renewal at the same rates as last year for contract year July 1, 2025 through June 30, 2026. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Kelvin Abrashoff requested consideration of approval to hire Kyra Hand for the position of Caseworker 2 effective June 23, 2025. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

Consideration of approval was given for Sarah Snare to attend the annual Prothonotary Conference. This is a budgeted expense. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Walls, yes; Reeder, yes).

Consideration of approval was given for Penn State Construction Change Order #22 for railing installation in the retaining wall on the new addition. This was missed in the initial proposal. The total cost is \$1,946.39. It was moved by Commissioner Reeder, seconded by Commissioner Walls and carried (Reeder, yes; Walls, yes).

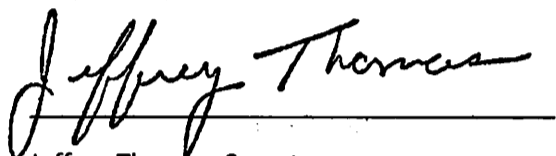
There were no Matters for Action.
