

The regular meeting of the Huntingdon County Commissioners was held on the above date and time in the Commissioner's Meeting Room with the following present: Commissioners Walls, Thomas, and Reeder; Solicitor, Larry Newton; Chief Clerk, Heather Fellman; Court Administrator, Angela Robinson; Mike Hannon and Micaela Mills from Tri-County Drug and Alcohol; Sarah Pilacik from the Eastern PA Bleeding Disorders Foundation; Commissioners Office Intern, Jackson Sharpe and Daily News Reporter, Joe Thompson.

The meeting was called to order at 9:30 a.m. by Commissioner Walls. Prayer was led by Commissioner Walls and the Pledge of Allegiance to the flag was led by Thomas.

Consideration of approval was given for Penn State Construction Change Order #13 to convert the new women's staff restroom area to more office space. There is no cost associated with this change order. It was moved by Commissioner Reeder, seconded by Commissioner Thomas and carried (Thomas, yes; Reeder, yes; Walls, yes).

Consideration of approval was given for Penn State Construction Change Order #14 to modify a door for ADA compliance. The cost for this change is \$1,680.47. It was moved by Commissioner Thomas, seconded by Commissioner Reeder and carried (Reeder, yes; Walls, yes; Thomas, yes).

Consideration of approval was given to appoint David Hsiung to the Library Board. It was moved by Commissioner Reeder, seconded by Commissioner Thomas and carried (Walls, yes; Thomas, yes; Reeder, yes).


There were no Matters for Action.
