NOTICE OF TAX SALE

**Notice is Hereby Given That The Tax Claim Bureau of Huntingdon County
Will Hold An Upset Sale of Various Properties On
Monday, September 21, 2026 At
6:00 P.M. Prevailing Time**

in the Bailey Building at 233 Penn Street, Huntingdon, Pennsylvania. The properties will be sold at not less than the Upset Prices hereinafter stated for the purpose of compliance with the Real Estate Tax Sale Law of 1947 and its amendments, to obtain the delinquent taxes, costs and expenses due to the various taxing districts.

All prospective bidders must register in person with the Huntingdon County Tax Claim Bureau at 233 Penn Street Huntingdon PA beginning August 19, 2026, through September 3, 2026. This registration requires a photo I.D. such as a valid driver's license or other form of identification acceptable to the Tax Claim Bureau. There is a nonrefundable \$25 registration fee. You must be present to bid. Bids may not be assigned.

No sale of property will be consummated unless a bid is received equal to or greater than the Upset Price.

The sale of any property may, at the option of the Tax Claim Bureau, be stayed if the owner thereof, or any lien creditor of the owner enters into an agreement with the Bureau to pay the taxes in installments in the manner provided by the Real Estate Tax Sale Law and makes such payments as are required and agreed upon. Any such agreement must be made before the date of sale.

The Real Estate Tax Law provides that: "There shall be no period of redemption after such sale and the sale shall be deemed to pass a good and valid title to the purchaser."

Every such sale shall convey title to the property under and subject to the lien of record.

CONDITIONS OF SALE

The property so struck down will be settled before the next property is offered for sale. Payments must be made by check drawn on a local bank or in another form acceptable to the Tax Claim Bureau.

Deeds for the premises will be prepared by the Tax Claim Bureau. Once the deeds have been prepared, the buyer will be contacted to pick up the deed. The buyer shall be responsible for recording the deed in the Recorder of Deeds Office and paying all costs associated with recording the deed, including the recording fee of \$58.75, the UPI fee of \$20.00 per parcel, and any applicable realty transfer taxes.

It is strongly urged that prospective purchasers have an examination made of the title of any property in which they may be interested. Every reasonable effort has been made to keep the proceedings free from error. However in every case the Tax Claim Bureau is selling the taxable interest and property is offered for sale by the Tax Claim Bureau without any guarantee or warranty whatever. All sales will be made under these conditions and will be final. No adjustment will be made after the property is struck down.
